



# INFINITE BEINGS ASSOCIATION

## PRIVATE MEMBERSHIP AGREEMENT

In order to obtain service and/or goods from For the Culture Ministries you must join Infinite Beings Private Membership Association(the Association) which protects our rights as free living people and protects the members providing services and goods for other members. The yearly membership fee of \$88 must be paid before you can obtain services and goods.

### Summary of this Agreement

- You are joining a **private association** protected by the Infinity Scrolls for Infinite Beings in America and 1st Amendment of the Organic United States Constitution, to obtain services and goods directly from the other members.
- You are choosing for yourself the types of goods and services you want to buy, and you have done your own research on the topic.
- You will not file a liability lawsuit against the Association, trustees, staff, or the other members for anything pertaining to the goods and services you obtain of your own free will.
- Your activities and the service activities within the Association are private and not to be shared with the FDA, FTC, USDA, any State Board of Health, policing agencies, Agricultural Boards, State Medical Boards or any other governmental agencies.
- You are not a State or Federal agent whose purpose is to regulate, report and/or approve service or goods provided.

### Membership Contract for Infinite Beings Association (IBA)

The Member does hereby apply for membership to IBA, a private membership organization facilitated by trustees For the Culture Ministries. By autographing this membership agreement, the Member accepts the offer made to become a member of Infinite Beings Association and has read and agrees with the following Declaration of Purpose from Infinite Beings Association:

1. This Association of members hereby declares that our main objective is to maintain the rights of members as free people and especially the right to contract and purchase goods and services in their private capacity. IBA is governed by Infinity Scrolls for Infinite Beings in American and supported by the Organic Constitution of the United States of America.
2. Our members have the rights of free speech, petition, assembly, and the right to gather together for the lawful purpose of communing and helping one another in asserting our divine rights as protected by the Infinity Scrolls for Infinite Beings in America and supported by the First Amendment of the Organic Constitution of the United States of America.

IT IS HEREBY declared that we are exercising our right to contract and self-govern as encoded in Infinity Scrolls and the right of “freedom of association” as guaranteed by the 1<sup>st</sup> amendment of the Organic Unite States Constitution and equivalent provisions of the various State

Constitutions. This means our association activities are in the private domain only.

3. We proclaim the **freedom to choose and decide for ourselves the types of products, services, and methods of delivery that we think are best for our lives, liberties and security of person including health, community betterment, education, land development, housing, spiritual wellness, agriculture, travel and any other needs or desires that may arise.** We proclaim and reserve the right to spiritual freedoms including practices used by any types of healers or health practitioners the world over whether traditional or nontraditional, conventional or unconventional.
4. More specifically, the mission of the Association is **to provide members with the freedom guaranteed to them as humans protected the Infinity Scrolls and supported by the Organic Constitution of the United States of America ad Universal Declaration of Human Rights.** We offer members access to goods and services in their private capacity. The Association understands that access is the foundation to equity and wellness. The Association strives to provides access to good and services by the most effective means of delivery.

More specifically, **the Association specializes in protecting our rights to contract freely and be protected from outside interference.** The Association offers its members alternatives to securing goods and services from public entities.

5. The Association recognizes all living people who are in accordance with these principles and policies and join as members and provides a medium through which its individual members may associate for bringing the purposes declared to fruition.

## MEMORANDUM OF UNDERSTANDING

I(the prospective member) understand the fellow members of the Association providing products and services, do so in the capacity of a fellow member and not in the capacity as a licensed professional, wholesaler, retailer or provider. I further understand that within the Association no wholesaler/retailer-customer relationship exists but only a member to member relationship through the Association agreement.

In addition, I have freely chosen to change my legal status as a public consumer/customer to a lawful status of private member of the Association. I further understand that **it is entirely my own responsibility to research the recommendations and products offered to me by my fellow members and to educate myself as to the efficacy, risks, and desirability of the goods and services and accept or decline the offered or recommended goods and services** after my own careful considered.

Any request by me to a fellow member to assist me or provide me with the aforementioned recommendations, goods, and services is my own free decision in an exercise of my rights and made by me for my benefit, and I agree to hold the Trustees, staff and other members and the Association harmless from any unintentional liability for the results of such recommendations and products, except for harm that results from instances of a clear and present danger of substantive evil as determined by the Association trustees and or committee.

The trustees approve providers for the Association that meet their standards and offer quality services and products. All complaints are to be submitted to the trustees and or committee for review. Contact

information and formal complaint process is shared with members after they autograph the agreement and receive confirmation of membership.

In addition, I understand the Association is protected by the laws encoded in the Infinity Scrolls and the First amendment to the Organic Constitution of the United States of America, it is outside the jurisdiction and authority of Federal and State Agencies and Authorities concerning any and all complaints or grievances against the Association, any trustees, members or other staff persons. All rights of complaints or grievances will be settled by the Trustees and/or Association Committee and all rights to sue are waived by the member for the benefit of the Association and its members.

The privacy and security of membership records are maintained within the Association, by autographing below, I waive complaint and lawsuit process in the public. All member records are private and only released by written request of said member. I agree that violation of any waivers in this membership contract will result in removal from the Association and immediately removal of any complaints or lawsuits filed in the public. In addition, the Association does not participate in any insurance plans.

**I agree to join the Infinite Beings Association, a private membership association protected by the Infinity Scrolls for Infinite Beings in America and supported by common law and the Organic United States Constitution**, whose members seek to help each other access high quality good and services and protect their rights as free living beings with divine inalienable rights.

I understand the providers who are fellow members of the Association are offering me products, services and benefits that do not necessarily conform to conventional products on the market.

As a member, I accept the goals of building community in which all members feel safe and protected and have equitable access to all goods and services. Other aspects of informed consent will take place in my discussions with the members providing services and goods to fellow members of the Association.

**My activities within the Association are a private matter that I refuse to share with the FDA, FTC, USDA, any State Board of Health, policing agencies, Agricultural Boards, State Medical Boards or any other governmental agencies.** All records and documents remain as property of the Association, even if I receive a copy of them. **I fully agree not to file a liability lawsuit against a fellow member of the Association**, unless that member has exposed me to a clear and present danger of substantive evil outside of Association activities and the Association Trustees give written explicit consent. I acknowledge that the members of the Association do not carry liability insurance.

The Trustees shall have the right to sanction a member upon unanimous vote of the Trustees, after a hearing of the facts where the member may be present after notification of complaint. The sanctions include removal from active membership or imposing any other special and necessary conditions upon any member who shall discredit or bring harm to the Association in any manner.

I enter into this agreement of my own free will or on behalf of my dependents without any pressure or promise of products. **I affirm that I do not represent any State or Federal agency whose purpose is to regulate and approve products or services.** I have read and understood this document, and my questions have been answered fully to my satisfaction. I understand that I can withdraw from this agreement and terminate my membership in this association at any time. However, I still may not file

any public claims about activities that happened between members during my membership. These pages and the articles of association of the IBA consist of the entire agreement for my membership in the Association, Infinity Scrolls for Infinite Beings in America and they supersede any previous agreement.

I understand the membership fee entitles me to access to goods and services of member providers and benefits declared by the Trustees and provided by the Association. All records and personal data collected by the Association is held privately and not shared with any outside entities for any reason without the written consent of said member. The information contained in this document is intended only for the individuals and entities entering into this agreement and any dissemination, distribution or copying is strictly prohibited.

## Membership fee
